



CIMB BANK PH 15% P.A CAMPAIGN & PERIOD

- The CIMB BANK 15% PER ANNUM (P.A) PROMO ("this Campaign") is intended to reward eligible new and existing CIMB Bank Philippines Inc. ("CIMB Bank PH" or "Bank") Customers in recognition of their patronage and loyalty to CIMB Bank PH
- This Campaign runs from January 1 to January 31, 2025 ("the Campaign Period").
- This Campaign consists of multiple Promos wherein a CIMB Bank PH Customer may earn up to 15% p.a. interest rate.

ELIGIBILITY

4. A CIMB Bank PH customer (the "Customer") will be considered eligible (the "Eligible Participant") for a Promo under this Campaign only if the Customer is a GSave or UpSave accountholder with open and unblocked account(s) during the Campaign Period and fulfills ALL of the conditions ("Qualifying Criteria(s)") under this Section and under each promo. No other deposit accounts are eligible for this Campaign.

A. EARN 3.50% P.A. INTEREST RATE AT NO ADB CAP

- Customer must have at least one active and unblock UpSave and/or GSave account during the Campaign Period. Other deposit accounts are not eligible.
- b) The 3.50% p.a. interest rate is inclusive of the regular base rate of 2.5% p.a. for UpSave and 2.6% p.a. for GSave accounts and other promo/s.

- Total ADB growth within the Campaign Period must be performed via Customer-initiated cash-in transactions via InstaPay, PESONet, Dragon Pay, GCash and/or over-the-counter bank

- Only successful Customer-initiated cash-in transactions made within the Campaign Period will be considered. Any delays in cash-in posting of funds shall not be counted, regardless of the cause of delay.
- For Customers who have multiple UpSave and GSave accounts with CIMB Bank PH, the applicable interest rate reward will be computed based on the Campaign Period's Total ADB growth:
 - To calculate the ADB, a Customer must sum all his/her balances at the end of each day of the Campaign Period and divide by the total number of days of the Campaign Period.
 - b) For newly opened accounts, the ADB will be computed from the day the account was opened (the "Account Opening Date"). Starting from the Account Opening Date, a Customer must sum all his/her balances at the end of each day and divide by the total number of days from Account Opening Date to the end of day of the Campaign Period.
 - c) To calculate the Total ADB, a Customer must add all the ADBs of their UpSave and GSave accounts within the same Qualifying Month.

CAMPAIGN REWARDS & CONDITIONS FOR PAYMENT

Grow Total ADB by a minimum amount of PhP 1,000.00.	Earn additional 1.0% p.a. interest rate, to be applied to Customer's Total ADB growth only compared to the previous month's Total ADB, with no limit as to the amount of Total ADB growth for purposes of computation of interest (No ADB growth cap!).
Grow Total ADB by a minimum amount of PhP 5,000.00.	Earn additional 2.5% p.a. interest rate, to be applied to Customer's Total ADB growth only compared to the previous month's Total ADB, with no limit as to the amount of Total ADB growth for purposes of computation of interest (No ADB growth cap!).
Grow Total ADB by a minimum amount of PhP 10,000.00.	Earn additional 3.5% p.a. interest rate, to be applied to Customer's Total ADB growth only compared to the previous month's Total ADB, with no limit as to the amount of Total ADB growth for purposes of computation of interest (No ADB growth cap!).
Grow Total ADB by a minimum amount of PhP 50,000.00.	Earn additional 4.5% p.a. interest rate, to be applied to Customer's Total ADB growth only compared to the previous month's Total ADB, with no limit as to the amount of Total ADB growth for purposes of computation of interest (No ADB growth cap!).

- The Reward under each Promo shall be inclusive of all other applicable rewards under other ongoing campaigns, if any.
- The Reward/s earned will be credited to the Eligible Participant's UpSave and/or GSave by CIMB Bank PH account, less 20%

By participating in this Campaign, the Eligible Participant(s) hereby agree that CIMB Bank PH shall not in any manner whatsoever be liable or held responsible to the Eligible Participant(s) if CIMB Bank PH is unable to perform in whole or in part of any of its obligations herein, attributable directly or indirectly to the failure of any mechanical or electronic device, data processing system, transmission line, electrical failure, industrial dispute, war, strike, riot, any act of God beyond CIMB Bank's control or due to any factor in a nature of a force majeure which is beyond CIMB Bank's reasonable control.

CIMB Bank PH shall not be liable to any Customer or Eligible Participant(s) or any party for any loss or damage of whatsoever nature suffered (including but not limited to, loss of income, profits or goodwill, direct or indirect, incidental, consequential, exemplary, punitive or special damages of any party) howsoever arising, in relation to the participation or non-participation in this Campaign including arising from any non-receipt or delayed receipt by Eligible Participant(s) of the Electronic Direct Mail ("EDM") and Short Message Service ("SMS"), except to the extent that such loss, liability, claim or damages directly and solely arises from CIMB's own gross negligence or willful misconduct as duly proven in a tribunal of competent jurisdiction.
